

Membership Application - Check the membership desired with the payment choice. Fill out application.

Any capital fund not paid in full at time of application, carries an administrative fee of \$70.00.

Payroll deduction is an option available for active Boeing employees only.

Boeing Employees Share – Tennis & Racquetball

- Option 1 - \$937.77 payment includes 1st quarters dues
 \$845 payment, with monthly dues via payroll deduction. Fill out form for \$30.92/month
 - Option 2 - \$567.77 payment, with quarterly dues (\$147.77 for 8 more quarters)
 \$420 payment, with monthly dues via payroll deduction. Fill out form for \$49.25/month
 - Option 3 - zero payment with monthly dues via payroll deduction. Fill out form for \$107.17/month for 12 months.
- With all payment options, once the share deposit and capital fund are paid, dues are \$30.92 a month or \$92.77 a quarter.

Boeing Employees Share – Racquetball/Handball

- Option 1 - \$330.93 payment includes 1st quarters dues
 \$300 payment, with monthly dues via payroll deduction. Fill out payroll deduction form for \$10.31/month
 - Option 2 - zero payment, with 3 monthly payments via payroll deduction. Fill out payroll deduction form for \$110.31.
- With all payment options, once the share deposit and capital fund are paid, dues are \$10.31 a month or \$30.92 a quarter.

Associate Membership - Tennis & Racquetball - Public Family Program

- Option 1 - \$564.16 payment includes 1st quarters dues
 - Option 2 - \$194.16 payment and for 8 more quarters
- With all payment options, once the capital fund is paid, dues are \$139.16 a quarter.

Associate Membership - Racquetball & Handball - Public Family Program

- Option 1 - \$146.39 payment includes 1st quarters dues of \$46.39

Junior Affiliate Membership - Tennis & Racquetball - Under 21 years of age

- Option 1 - \$548.70 payment 1 junior - \$595.08 payment 2 juniors - \$646.63 payment 3 or more juniors
 - Option 2 - \$178.70/1 jr, \$225.08/2 jrs, \$276.63/3 or more jrs - covers first 6 months dues and 1st qtr of capital fund.
- Billed 8 more qtrs at \$55 for capital fund & semiannual dues based membership-1 jr/\$123.70, 2 jrs/\$170.08 and 3+ jrs/ \$221.63.

B330 Membership - Tennis & Racquetball - Public Family Program

- Option 1 - \$502.31 payment, paying capital fund and quarterly dues of \$77.31.
- Option 2 - \$132.31 payment & for 8 more quarters then quarterly dues of \$77.31.

Summer Membership - Tennis & Racquetball - Public or Boeing Employee Program

- \$172.40 - payment which is \$117.40 for membership dues and \$55.00 for the capital fund

USTA Membership - Tennis & Racquetball - Public or Boeing Employee Program

- \$106.38 - payment which is \$46.38 for membership dues and \$60.00 for the capital fund
