ELIGIBILITY

The tournament is open only to active BETC members. Junior members age 14 & above are welcome in NTRP divisions.

PRICING

Singles – **\$30+tax**. Doubles/Mixed Doubles — **\$20+tax** (per player)

FORMAT/SCORING

Players may enter only **TWO** events per weekend. All events are “**First Match Consolation**” format unless posted otherwise. Players **must** be available to play their scheduled main draw **AND** consolation matches.

Main Draw matches: One-Deuce No-Ad scoring, best 2 out of 3 sets, with a 10-point super tiebreak for the 3rd set. One can of tennis balls per match. Finals will be regular scoring.

Consolation matches: No-ad scoring, best 2 out of 3 sets with a 10-point super tiebreak for the 3rd set. One can of tennis balls per match.

CHOOSING AN EVENT

1. Members must enter at or above the level of their USTA/Club rating.
2. The tournament director has the option to place an individual in an event other than the one she/he signs up for if needed.

DRAWS/CHECK-IN

Players are responsible for finding out their time of play. **Draws will be posted by midnight the Tuesday the week of the tournament.** Match play will range from 5:00PM – 11:00PM (Friday), 8:00AM – 9:30PM (Saturday) and 8:00AM – 9:30PM (Sunday). **Players must check in 15 minutes prior to start time.** Defaults will be made 15 minutes after scheduled start time. **No refunds after draws are made.**

MISC.

Players will receive a commemorative BETC tournament shirt (one per player). Each player will receive a raffle ticket for a chance to win a brand new racquet & bag donated by Dave Demulling Pro Shop.
