Registration: Players can register for this event through the following methods.

Format: Single elimination format. All matches will be 2 out of 3 sets. 3rd set will be a Super Tie - breaker to 10. Regular scoring in all rounds.

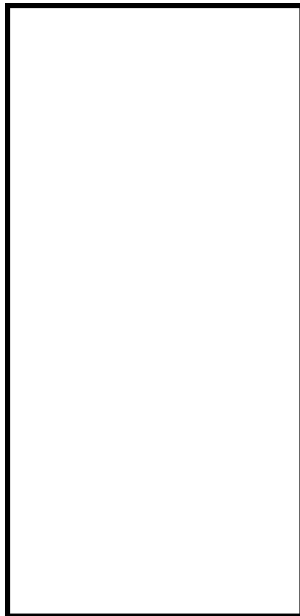

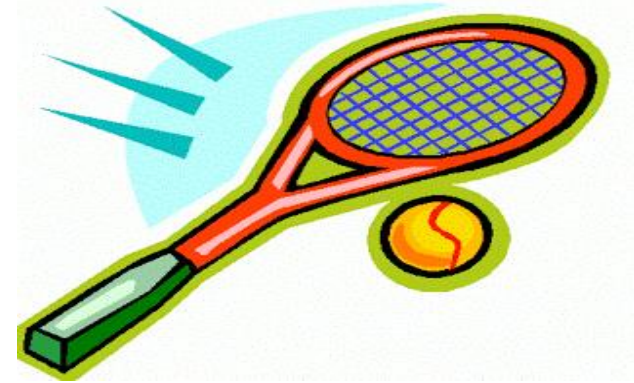
