#### **ELIGIBILITY**

The tournament is open only to active BETC members. Junior members age 16 & above are welcome in NTRP divisions.

#### **PRICING**

Singles – \$28 + tax. Doubles/Mixed Doubles — \$23 + tax (per player)

#### FORMAT/SCORING

Players may enter only **TWO** events <u>per weekend</u>. All events are single elimination. Players **must** be available to play their scheduled matches.

**Scoring:** Regular scoring, best 2 out of 3 sets, with a 10-point super tiebreak for the 3<sup>rd</sup> set. One can of tennis balls per match.

#### **CHOOSING AN EVENT**

- 1. Members must enter at or above the level of their Club rating. If a Club rating is not available, a USTA rating will be used. If neither rating is available, the entry will be subject to tournament director approval.
- 2. The tournament director has the option to place an individual in an event other than the one she/he signs up for if needed.

#### DRAWS/CHECK-IN

Players are responsible for finding out their time of play. **Draws will be posted by midnight on Tuesday the week of the tournament.** Match play will range from 5:00PM – 11:00PM (Friday), 8:00AM – 9:30PM (Saturday) and 8:00AM – 9:30PM (Sunday). **Players must check in 15 minutes prior to start time.** Defaults will be made 15 minutes after scheduled start time. **No refunds after draws are made.**
